

WHEN YOU ENTER THE OAKWOOD ROOM YOU ACKNOWLEDGE THAT YOU ARE USING THE FACILITIES AT YOUR OWN RISK. COVID-19 MAY BE PRESENT.

In accordance with the Centers for Disease Control and Prevention (CDC), State of Arizona, and HOA Board of Directors, all residents are required to follow these guidelines.

- If sick, go home. Do not enter.
- Visitors and guests are not allowed entry.
- If you are at higher risk for severe illness, you should avoid this area. People at higher risk for severe illness include adults 65 or older and people of any age who have serious underlying medical conditions.
- Wash hands with soap and water.
- Use hand sanitizer if soap and water is unavailable.
- Wash/sanitize hands before, during, and after use of equipment.
- Disinfect all equipment between uses.
- Maintain a minimum six feet social distancing from other residents at all times.
- Utilize a cloth facial covering or mask. Masks are not a substitute for staying six feet away from others.
- Do not touch your eyes, nose, or mouth.
- Bring your own water bottle, tissues, and hand sanitizer.
- HOURS ARE 12:15 P.M. UNTIL 3:00 P.M. MONDAY AND WEDNESDAY.
- LIMIT TO EIGHTEEN (18) TABLES.
- ONE (1) PERSON PER TABLE MAXIMUM.
- REFRIGERATOR AND FREEZER IN PALO VERDE KITCHEN WILL REMAINED LOCKED.
- SANITIZER WILL BE PROVIDED BY THE ASSOCIATION FOR NOW.
- PRIOR TO LEAVING THE ROOM CLUB MEMBERS WILL CLEAN AND DISINFECT ASSOCIATION TABLES, CHAIRS, TOOLS AND ANY OTHER EQUIPMENT USED BY CLUB MEMBERS DURING THE EVENT. ASSOCIATION WILL PROVIDE THE DISINFECTANT.
- CLUB MEMBERS WILL PROVIDE THEIR PERSONAL HAND SANITIZER AND DISINFECTANT FOR ALL PERSONAL ITEMS USED BETWEEN THE HOURS OF 12:15 P.M. AND 3:00 P.M.
- TRASH WILL BE REMOVED FROM THE OAKWOOD ROOM AT THE END OF THE DAY BY MEMBERS USING THE ROOM BETWEEN 12:15 P.M. AND 3:00 P.M.
- PRIOR TO LEAVING THE ROOM FOR THE DAY MEMBERS SHOULD SWEEP THE FLOOR OF NEEDLES, THREAD, ETC. MAINTENANCE WILL SWEEP AND MOP THE FLOOR EACH MORNING.

- AT THIS TIME THE OAKWOOD ROOM WILL NOT BE USED BY OTHER GROUPS, HOWEVER, IT IS SUBECT TO CHANGE. ROOM USE HOURS ARE TO BE STRICTLY ENFORCED.
- THE HOURS OF USE ARE SUBJECT TO CHANGE. GUIDELINES WILL BE REVIEWED AND REVISED AS NEEDED.
